**TERMS & CONDITIONS FOR THE PERMISSION FOR USING THE GOVT. LAND
SITUATED AT GANESHNAGAR GROUND, GHOGHLA FOR THE PURPOSE OF
ORGANIZING ANAND MELA**

1. A Public Auction for the permission for using the Govt. Land situated at Ganeshnagar Ground, Ghoghla for the period of 01 month from 15/12/2022 to 15/01/2023 for the purpose of organizing Anand Mela.
2. The starting bid for the Public Auction will be 50,000/- per day.
3. The participants have to deposit Rs. 10,000/- before 08/12/2022, 6 P.M. for participating into the Public Auction (Non-Refundable) by Online Mode i.e. POS, UPI etc.
4. The contractor participating in the auction should produce PAN card and Aadhaar Card.
5. The bidder should have one year experience of organizing Mela with rides in U.T. of DNH & DD or three years of said experience anywhere outside of U.T. The bidder shall have to prove the experience by providing experience certificate along with photograph.
6. Every bid call should in multiple of one thousand rupees.
7. The highest bidder has to deposit 10% of the offered amount within one day after issue of order in the form of FDR in the name of "Chief Officer, Diu Municipal Council, Diu".
8. The highest bidder has to obtain NOC for Temporary Electric Connection from Diu Municipal Council, Diu in his name.
9. The highest bidder has to obtain all the relevant NOC from the Govt. Departments on his name and he/she shall have to pay the necessary fees for the permission at the respective department.
10. The highest bidder has to avail the insurance of more than Fifty Lakh and submit the insurance report to the Council.
11. The highest bidder shall be sole responsible for any kind of accident caused or loss to the Govt. Property during the Anand Mela.
12. All the safety norms for organizing Mela as per national permissions are to be followed by the successful bidder and he/she has to submit documents for it in compliance to all respective authorities.
13. The highest bidder shall ensure to maintain social distancing including wearing of masks and using hand sanitizers.
14. The maximum number of attendees/guests shall not be more than 200 people at a time.
15. Necessary parking arrangements shall be made by the organizer.
