TERMS & CONDITIONS FOR COLLECTION OF CHARGES IN RESPECT OF DISPOSAL OF CONSTRUCTION AND DEMOLITION WASTE FROM ENTIRE DIU MUNIC=IPAL AREA

- 1. A Public Auction for the contract of Collection of Charges in respect of disposal of Construction and Demolition Waste from entire Diu Municipal area.
- 2. The Contract will be for the period of One Year from the date of issue of the Order.
- 3. The contractor will be authorized on behalf of Diu Municipal Council, Diu for collection of charges in respect of disposal of Construction and Demolition Waste from entire Diu Municipal area. The fees to be collected by the Contractor shall be as under:
